<input type="checkbox"/>	A photocopy of my birth certificate.
<input type="checkbox"/>	Evidence of name change, if your current name differs from that on your birth certificate and/or transcript e.g., driver's licence, passport, marriage licence, or other government-issued ID.
<input type="checkbox"/>	Proof of professional liability insurance (PLI) that meets the requirements e.g., through the Denturist Society of NS or another liability insurance that meets the requirements)
<input type="checkbox"/>	A copy of my current permanent CPR certificate, at the level required by the Board taken within the last 12 months (typically called BLS or HCP). The level of CPR certification must include, at a minimum, classroom instruction and practicum experience related to: <ul style="list-style-type: none"> • one and two-person rescuer chest compressions for adults, children and infants; • one and two-person rescuer adult, child and infant bag-valve-mask technique and rescue breathing; • relief of choking in adults, children and infants; and • use of an automated external defibrillator (AED).
<input type="checkbox"/>	<u>36 hours</u> of continuing Denturism education within the 3 years immediately before the date of my application (does not apply to applicants who graduated within the last 36 months) entered in the application form.
<input type="checkbox"/>	Evidence that I have practiced <u>600 hours</u> of denturism in the 3 years immediately before the date of my application (does not apply to applicants who graduated within the last 36 months). If applicable, this must be in the form of a letter from the employer (on letterhead), CRA submission, e.g., ROE (Record of Employment).
<input type="checkbox"/>	A passport-like picture (full facial profile) in a format appropriate for a regulator e.g., business casual clothing.
<input type="checkbox"/>	Evidence of successful completion of the NS Jurisprudence Examination offered through the NSRDHDTD, which can only be taken once you <u>submit an application</u> for registration and licensure. The cost to take the online exam is \$50. Once the fee is deposited into our account, you will be provided with a link to the exam.

<input type="checkbox"/>	Successful completion of the written and OSCE (Objectively Structured Clinical Examination) denturist qualifying or registration examination approved by the NSRDHDTD e.g., the examinations administered through the College of Denturists of Ontario, College of Alberta Denturists, and British Columbia.
<input type="checkbox"/>	Certificate of Completion of any modules completed <i>separately</i> from your DD undergrad program e.g., Dentures Over Implants.

<input type="checkbox"/>	My employment visa or permanent resident card under Canadian Immigration Act (non-Canadian citizens only)
<input type="checkbox"/>	Copy of any English language proficiency tests completed (Only required if mother tongue is not English and/or the Denturism program was delivered in a language other than English)
<input type="checkbox"/>	I am applying to have my Dentures Over Implants competency recognized. Therefore, I have indicated my intent on my application form and provided any required documentation (e.g., original transcript with the education, or post-grad certificate; and evidence of currency if I completed the education more than 3 years ago). – <i>Note:</i> These procedures are not mandatory to obtain a practising licence in NS, but you cannot perform this competency set unless you are authorized by the NSRDHDTD.
