Dental hygienists are treating more older adults as this age group continues to grow. In Canada, the majority of those ages 65 and older live independently in private homes, either alone or with a spouse.1 Thus, dental hygienists are most likely to encounter these communitydwelling older adults in private dental offices or community-based clinics. Approximately 20% live alone, among whom higher rates of poverty and social isolation are frequently observed, as well as reduced quality of life and poor health outcomes.<sup>1,2</sup> Older adults present with numerous chronic diseases of aging, including heart disease, diabetes, osteoarthritis, respiratory disorders, and neurological conditions, such as stroke and cognitive decline. Psychosocial health disorders, notably depression and anxiety, are also common. These, and other conditions, increase risk for missing teeth and poor overall health.3-5 Further, medications used to treat chronic disorders may also negatively impact general and oral health.

#### **Physiologic Changes with Aging**

Normal physiologic changes with aging alter pharmacokinetics. As a person ages, drug absorption may be altered by slowing of gastric activity and changes in gastric pH. Decreased production of plasma proteins means that more drug remains unbound in the circulation, allowing a greater percentage to leave the circulation to interact with target tissues. When a person takes multiple medications, more drug molecules compete for fewer binding sites, so an even greater percentage of the drug leaves the circulation for distribution to target sites, but also to sites where drug effects are not desired. The individual may experience an extension of the desired therapeutic effect and/or a greater number of side effects. This is especially problematic for older adults who frequently experience added central nervous system side effects (e.g. confusion and sedation) caused by distribution of drugs across the blood brain barrier. With aging, there is decreased lean muscle mass and increased fat, where lipid-soluble drugs may be stored and slowly released over time. Most drugs used in dentistry are lipid-soluble and are metabolized by the liver to water-soluble metabolites for excretion by the kidneys. Both liver and kidney function decline with age. Drug metabolism and excretion may be further compromised in those with liver



All of these experiences have underscored the saying "together we're better", as we see learn to listen and see things from others' viewpoints and lived experiences.

At the CDHNS office, during this time period, we have also had a staffing change, when we extended best wishes to Neha Singh and welcomed Jasleen Kaur as CDHNS Administrative Assistant. I would like to personally thank both Kelly and Jasleen for their tireless work as they consistently demonstrate the core staff values, including excellence in service and professional integrity. They have demonstrated their ability to quickly transition and change gears, as required.

I would also like to express my gratitude to the numerous CDHNS registrants who served in different capacities as committee volunteers, including Council. They have dedicated their time and expertise to assist the CDHNS in fulfilling its regulatory roles and responsibilities.

As the province prepares for the fifth phase of their COVID-19 plan, all four provincial oral health regulators continue to work together to give guidance to our respective registrants to navigate this transition. We will keep you updated as we progress.

Simultaneously, as Hilary Boudreau, past Council Chair, shared during the Annual General Meeting in May 2021, we are also preparing for the regulation changes, submitted to Government in Jan 2020. We will continue to send communications from the CDHNS regarding upcoming changes, and any necessary actions required by CDHNS registrants.

**Expiry Notices:** All expiry notices will be sent to registrants by email. <u>Online renewal</u> is mandatory for all

registrants. It is the registrant's responsibility to ensure that they hold a valid practising licence at all times, regardless of notice sent or other circumstances.

We will be using a similar online process as the past three years. The steps are outlined in more detail in the expiry notice email you will receive at the end of August.

After logging in, your first step will be to complete a questionnaire and select the action you wish to do during this renewal e.g., I am currently in the **Practising** class and I want to renew in the **Practising** class. Once you've indicated your intention, you will be taken to the next step required for the action you chose.

Licence Renewal Period: The licence renewal period will start on September 1, 2021 and run until October 4, 2021 (11:59 pm). The renewal portal will remain open until October 31, 2021.

At the April 17, 2021 CDHNS Council meeting, Council set the renewal deadline for the 2021/22 year to **October 4, 2021 (11:59 pm)**. For the past six years, the renewal deadline has typically been set for the first Monday of the month.

Although October 31 is the licence expiry date, the CDHNS was advised by legal counsel to allow sufficient time to review and process the increased number of applications and to follow up on any inquiries which resulted from licence renewal applications. This timeframe

The CDHNS staff must review all 800+ applications, complete any necessary follow up, review and approve CPRs, accept and apply the fees, manage receipts, and email new licences for November 1, 2021. This process takes time. Assist the staff in processing all applications in a timely manner by completing all the necessary steps, as outlined in this section and in the detailed email you will receive.

ensures that registrants receive their licences prior to November 1 and do not experience any disruption in their ability to practice. Accordingly, all information must be received by the CDHNS by the specified date on the renewal notice.

A complete application, including payment of fees and any other requirements e.g., CPR at the level specified by Council, must be received by the October 4, 2021 deadline.

Individuals must meet the Council-set deadline of October 4, 2021 to submit a complete application, including payment of fees and all other requirements. Individuals who do not meet the Council-set deadline of October 4, 2021 but submit a complete renewal application **between October 5 and October 31, 2021** will be required to pay additional fees. During this time period:

- Registrants wishing to renew their practising licence must pay an additional \$100 payment.
- Registrants wishing to renew in the non-practising licence category must pay an additional \$20 payment.
- Registrants who do not renew by October 31, 2021
  will no longer hold a licence. If they want their licence
  renewed, they will be required to pay reinstatement
  fees, in addition to the \$100 payment, and will be
  required to provide proof they have met all other
  licensing requirements.

If you renew between October 5 and 31, 2021, you are considered to have missed the Council-set deadline of October 4, 2021. If repeated and flagrant violations of these deadlines and the renewal process occur, a complaint may be referred to the Investigation Committee.

### Reminders re: Online Renewal for CDHNS Registrants in the Practising Class

Practising registrants may renew online in the practising class or transfer to the non-practising class.

**CPR:** As part of the online process for renewing as a practising registrant, the system will confirm that your CPR certification will be current on **November 1, 2021**. If CPR certification was completed 12 or more months **prior to** November 1, 2021, the system will not allow you to proceed with online renewal as a practising registrant until an updated CPR card/certificate, at the level required by Council, has been uploaded and approved by CDHNS staff.

Complete the following steps:

- 1. Log into the system at www.cdhns.ca > Member Login > enter your user name and password.
- 2. Scroll down the right-hand side of the page and select Upload your CPR.
- 3. Once approved by CDHNS staff, you will receive an email notifying you of the approval.
- 4. The CPR section of your Member Profile will indicate that your CPR has been approved for the renewal year November 1, 2021 to October 31, 2022.

**Practice Hours:** The next step will be to add your practice hours. All CDHNS registrants who were practising during all or part of the November 1, 2020 to October 31, 2021 renewal year will be required to list the total number of practice hours worked from Nov 1, 2020 to Oct. 31, 2021. You must enter your practice hours into the system even if you intend to transfer to the non-practising class for 2021/22.

- 1. For those wishing to obtain a practising licence for the 2021/22 year who graduated more than 3 years prior to application, and whose practice hours cycle runs from Nov 1, 2018 to Oct 31, 2021, you must have practiced a minimum of 600 hours in dental hygiene within the last 3 years. (These practice hours may have been accumulated here in NS or in another jurisdiction where you were licenced to practice dental hygiene).
  - o If you have not practiced the requisite number of practice hours within the last 3 years, the Registrar will contact you to discuss further options, once you've entered in your hours on the system.

Once all required elements have been entered (and approved in the case of the CPR), your renewal button will show at the bottom of the left side of your member portal, and you will be able to proceed through renewal – update your profile, answer the good character questions, and generate an invoice to make payment.

### Reminders re: Online Renewal for Non-Practising Registrants

Non-practising registrants may renew online in the non-practising class or transfer to the practising class *if* the criteria are met. Your response on the questionnaire, at the beginning of the renewal process, will determine the pathway for renewal.

Non-practising registrants wishing to transfer to the practising class must meet the requirements for licensing as outlined in the Regulations. Allow a minimum of 2 weeks for the Non-Practising to Practising process

**to be completed.** For those who graduated three or more years ago, in addition to CPR, you must also provide evidence of having completed the following requirements 3 years immediately before applying for a practising licence:

- having practiced within the last 3 years, and
- having obtained 45 hours (credits) of continuing education, as set by Council. (For information on the 45 hours criteria, refer to the <u>Continuing Competency</u> <u>Program Requirements document.</u>)

**Know the Facts:** Trying to decide whether you should renew as practising or non-practising for the 2021/22 renewal year? Carefully read the information included with the expiry notice email. Contact the CDHNS office if you require further clarification.

Standard practice for notice and reminders will be given for the 2021/22 renewal period. These standard practices are as follows:

- August 30, 2021 initial notice of licence renewal/ expiry is sent by email. This notice will also be available on the website, in the library folder entitled Renewal Information for CDHNS Members.
- A two-week email notice is sent prior to the deadline.
- A one-week notice by email prior to the deadline for those who have not renewed.
- November 1 the licence will expire.


It is your responsibility to ensure that the CDHNS has your up-to-date contact information, including your email address.

**Did you know?** (1) Based on registrant feedback, we have developed a Renewal Frequently Asked Questions document again. It is located in the Library of your Member Portal under the sub folder *Renewal Information for CDHNS Registrants*. (2) As advised for the last two years, the 2020/21 renewal was the last year we accepted personal cheques. We have multiple payment options — e-transfer, credit card payment through Plastiq, business cheques, certified cheques, money orders, and cash. Ensure that your payment is processed on time. Review the Notice of Expiry for payment options and deadline reminders.

### What constitutes dental hygiene practice in Nova Scotia?

Section 22 of the Act provides details regarding dental

hygiene scope of practice. In conjunction with the Regulations (including Sections 25 and 26: Scope of Practice), the practice of dental hygiene is defined. Only CDHNS registrants who hold a practising licence may engage in the practice of dental hygiene in Nova Scotia, whether as a volunteer or for remuneration. The practice of dental hygiene includes registrants who act as clinicians, educators, researchers, administrators, managers, health promoters, and/or consultants. When asked to report your practice hours, do not just calculate the hours you spent providing clinical care, include hours where you provided dental hygiene care in any of the areas noted above e.g., an educator, researcher, administrator, health promoter, or consultant. This may include positions like dental supply company sales rep, infection prevention and control consultant, and dental hygiene department manager. All positions count towards accumulation of practice hours and all positions.

#### May 15, 2021 CDHNS AGM/CC EVENT

The CDHNS Annual General Meeting was held virtually again this year, on May 15, 2021. Overall, it was very successful, with 436 CDHNS registrants registered to attend and voted. Prior to the start of the AGM, Wendy Stewart, (CDHA NS Director/CDHA President-Elect) presented a pre-recorded greeting from the CDHA, which included an update of the CDHA activities that occurred over the last year. Stacy Bryan, Registrar, welcomed everyone to the AGM. The general business was shared with all those in attendance, focusing on highlights in the Annual Report for the fiscal year, November 1, 2019 to October 31, 2020, including the audited financial statements. Hilary Boudreau, then CDHNS Chair, presented her message, including a regulation revisions update. Sonya Bishop, Chair of the Quality Assurance (QA) Committee's submitted report was circulated prior to the meeting and was declared 'filed' at the AGM. Mallory Brent, Chair of the Nominations Committee, reported on behalf of this committee. Dr. Mary McNally and Dr. Leigha Rock's pre-recorded session reviewed the return-to-work strategy that was developed, disseminated and evaluated early in the COVID-19 pandemic in Nova Scotia.

Immediately following the AGM, the CDHNS presented a continuing competency event, *Managing Conflict* 

by Building Healthy Relationships, presented by Diane Wooden. This event was live streamed using the Zoom platform with 261 registrants in attendance.

Both events were a success and we thank you for your participation.

205 participants completed the post-event(s) survey.

- 40% of respondents were rural; 57% were urban; and 3% were both.
- 93.53% rated the AGM good to excellent.
- 75.19% rated the CC event good to excellent.
- 94% responded that they would be interested in having CDHNS Council host an AGM via interactive live streaming again.

and kidney disease. These cumulative physiologic changes increase the likelihood for adverse drug events (ADEs), including drug overdose, and dosages may need to be reduced for older individuals.<sup>6</sup>

#### **Adverse Drug Events**

Known ADEs, including side effects, are well-documented and are listed in the drug monograph. Clinicians should be well-versed with how to look up medications using CPS from the Canadian Pharmacists Association, Health Canada's Drug Product Database, and the Canada Vigilance Program (MedEffect Canada). Access to an electronic drug database geared toward dental professionals and a drug-interaction software program are especially helpful tools for use when caring for older adults.

Drug interactions lead to numerous ADEs that compromise health and well-being. Older adults are especially vulnerable to ADEs. Drug interactions may alter all phases of pharmacokinetics and pharmacodynamics.<sup>7</sup> Polypharmacy and polyherbacy increase risks for drug:drug and drug:herbal and dietary supplement (HDS) interactions. Risk increases with increased numbers of drugs/HDS taken.<sup>7,8</sup> Drugs may also interact with foods and alcoholic beverages.<sup>8</sup>

The most common ADE that impacts oral health and function is drug-induced hyposalivation, which increases risk for infections (e.g. caries, periodontal disease and opportunistic infections) and alters both comfort and function. Hyposalivation may also contribute to digestive problems due to difficulties with breaking down and swallowing the food bolus. Clients with chronic dry mouth are at risk for choking and aspiration and may not be able to generate a productive cough to assist with clearance. Hyposalivation alters taste sensation, as saliva is necessary to carry tastants over the taste buds. Over 250 drugs are known to alter taste and smell. Older adults frequently complain that food does not taste good which may be partially explained by medication use.

Many drugs increase risk for falling. The exact number of drugs known to cause falls is unknown, as falling is not a recognized ADE.<sup>11</sup> However, fall risk increases with age, as well as with neurological disorders, sensory impairments, reduced mobility, chronic disease and drug use.<sup>11</sup> Antidepressants are associated with the greatest fall risk, as are other drugs known to cause postural hypotension. Clinicians should reduce environmental risk factors in the office that contribute to fall risk, and monitor clients when arising from the dental chair.

Adherence with medication regimens is an ongoing challenge and difficulty increases with the number of medications taken. Those who live alone may require assistance with obtaining medications and monitoring for compliance. The number of health-related conditions that a person has, as well as the number of medications taken, frequency of dosing, and receiving and understanding education about prescribed medications all influence adherence. Dental hygienists play important roles with assessing compliance and providing education to promote proper medication management.

#### **Conclusion**

Dental hygienists are well-positioned to assess medicationrelated challenges and ADEs experienced by their older adult clients. Normal physiologic changes with aging may require dosage adjustments for drugs used in dentistry. ADEs that impact oral health and function should be documented and addressed to prevent oral infections and ensure comfort. Clinicians must be familiar with the numerous resources that are available to support decisionmaking at chairside to manage medicated clients safely. Dental hygienists can serve as important liaisons with primary care providers and pharmacists to advocate for their clients and to promote medication safety.

#### CPR Requirements for the 2021/22 Renewal

To assist you in understanding which CPR meets the list of requirements set by Council, a summary is provided below based on the organization's current offerings and levels.

#### St. John Ambulance

Based on the current course offerings and levels, the accepted course from St. John Ambulance would be Basic Life Support (BLS) CPR.

#### **Heart and Stroke Foundation**

Based on the current course offerings and levels, the accepted course from the Heart and Stroke Foundation is Basic Life Support (BLS).

**CPR Offerings:** There are a variety of organizations and providers across the province who provide CPR courses that meet the requirements for CDHNS renewal and initial licences in the practising class. As a courtesy to CDHNS registrants, a <u>CPR section</u> of the website indicates providers who have notified the CDHNS that they will offer courses for registrants based on the licensing requirements.

#### **Red Cross CPR**

Based on the current course offerings and levels, the accepted course from the Red Cross is BLS for Healthcare (HCP).

#### Lifesaving Society

Based on current course offerings and levels, the accepted course from NS's Lifesaving Society is CPR Healthcare Provider/AED.

**Did You Know?** On May 27, 2020, CDHNS
Council made the decision that CPR courses that include appropriate virtual evaluation of competencies will be accepted. For further details, please review the <u>updated CPR document</u> on our website. The CDHNS continues to monitor the situation and will update CDHNS registrants, if there are any changes.

CDHNS registrants must obtain and provide evidence of current CPR certification at the appropriate level so that you can proceed with renewal of, or transfer to, the practising licence class. Prior to enrolling in a CPR course, check with the provider to confirm how you will receive your certification and how long it will take to receive it. A temporary certificate is NOT acceptable.

#### How can you expect to get your CPR certification/card?

#### St. John Ambulance

If you take the course at a St. John Facility, you should receive your CPR Certification immediately after successful completion of the course. If you take this program through a contractor, you should also receive your certification immediately following successful completion of the course but it is your responsibility to confirm this at enrollment.

#### **Heart and Stroke Foundation**

After successful completion of the BLS course, you must log in to the Heart and Stroke Foundation website to access and print your certificate.

If you have already uploaded your CPR during this past year and had it approved, this section of your profile will already show that it's been approved for this upcoming renewal, i.e., .it will say

November 1, 2021 to October 31, 2022.

#### **Red Cross CPR**

Red Cross will provide you with a 30-day temporary certificate after successful completion of the course and require you to log in to their website to download official certification later. The 30-day temporary certificate is NOT acceptable for licensure. It is your responsibility to provide appropriate certification prior to the registration deadline.

#### **Lifesaving Society**

After successful completion of the course, the Lifesaving Society will mail you a hard copy of your certificate/card.

#### **CPR Approval Submission**

Upload your CPR now, rather than waiting to do so at the time of licence renewal. This will help to speed up your renewal process. Thank you for your cooperation.



#### **Notice from the Quality Assurance Committee**

On behalf of the Quality Assurance (QA) Committee, I would like to present some current items of interest.

The QA Committee has reviewed several online CE course providers following submitted requests from registrants. Decisions on current and previously reviewed online CE course providers can be found on the

public side of the CDHNS website under the <u>Continuing Competency</u> page, as well as on page 13 of this newsletter. The website will always have the most current one, since, at times, new providers are reviewed between newsletters.

The CDHNS Frequently Asked Questions (FAQ) Document is also available for registrants on the CDHNS website through the Member Portal (Log in required). Click on the Library section and go to the Practice Protocols & Policies folder.

The QA Committee met in August 2021, where the following decision was made, and then integrated the text into a revised CDHNS Continuing Competency Program document, which was sent to Council for approval.

This decision was made based on a review of CDHNS registrant feedback, and another review of existing Quality Assurance/Continuing Competency Programs and their requirements. All programs have a similar goal — they are intended to protect the public by providing parameters intended to help ensure that registrants remain safe and competent throughout their professional career. Further details are outlined in the email sent to all CDHNS registrants when the decision was approved by Council.

As of **October 1, 2021**, an acceptable alternative for verification of completion for Virtual learning activities (e.g., online learning) that meet CCP requirements but do not offer post-test evaluation is as follows:

A submitted verification of attendance, **along with** a completed <u>CDHNS Reflection document</u> that demonstrates the participant's learning.

One reflection document must be provided for each activity/course e.g., must complete a reflection document for each session offered during a one-day virtual event. The Reflection document must be uploaded on the CDHNS Professional Record at the time of entry for the learning activity.

Any learning activities completed *prior* to October 1, 2021, must meet the requirements that were in place in the previous CCP Requirements Document.

If the course/learning activity you are taking has a post-test, you must successfully complete it. This reflection plan document is for learning activities that do not have a learner assessment offered by the provider.

To minimize confusion, the CDHNS CCP requirements document in effect on Oct 1, 2021, will be circulated out to all registrants (and updated on the website) near the end of September. The FAQ document will also be updated to reflect the changes.

Do you find yourself inspired to be more involved with your dental hygiene profession? Curious about continuing competence and how 'all this works?' As two current QA Committee members are completing their terms at the end of November 2021, the QA Committee is seeking new members. As an outgoing QA Committee member, this experience has been most rewarding. ### How Long Do I Have to Retain My CC Records?

Registrants are required to retain relevant records/documents for your current cycle and your previous cycle (as noted in Section 4.5 of the CCP requirements document). Even if you are not selected for audit, you must ensure that you keep all relevant documents for these time periods.

#### **Assigning Credit Hours for Online Courses**

Completing online professional education is a convenient way for CDHNS registrants to identify their learning needs and seek out appropriate courses that meet those needs. You can learn at your own pace, anywhere. To support CDHNS registrants, the CDHNS Quality Assurance (QA) Committee evaluated a number of courses offered by online continuing oral health education providers.

Following these reviews, the QA Committee determined that the number of credit hours allocated by some course providers is not always consistent with the content of the courses. The Committee does revisit these course allocations on a regular basis to determine if changes are necessary. The Committee has reviewed the course providers identified and determined the following:

All online activities must meet the criteria to be eligible for credit hours e.g., must have a post-test that adequately covers the material. In addition to the general expectations noted above, below are a few sections of the CCP requirements that may be relevant to the course(s) you are considering:

- 3.1.5 (Formal Advanced Education Course or Programs)
- 6.1.5 and 6.3.2 (h) include criteria for individual self-study courses\*

# Call for Public Representative for the Nova Scotia Association of Architects' Governing Council

The Nova Scotia Association of Architects (NSAA) is seeking to appoint an individual to serve as one of its two public representatives on the NSAA Governing Council. The NSAA is the regulatory body for the architectural profession, whose purpose is to serve and protect the public interest in the practice of architecture in Nova Scotia. The NSAA seeks to foster and encourage diversity and inclusivity among its membership and Council, regardless of race, age, gender, identity, or disability.

The Public Representative cannot be a member of the architectural profession. The appointment of the Public Representative(s) is an effective mechanism through which the NSAA demonstrates transparency and accountability. This is a volunteer and unpaid position. The Public Representative will ensure that the public perspective is represented in the decision-making of the NSAA Council. They will have full voting rights, and will be expected to attend monthly Council Meetings, as well as the Annual General Meeting, either in person or virtually (via Zoom or another virtual platform). The Public Representative is also eligible to serve on various Committees within the NSAA; and they are expected to serve on either the Finance and Risk Committee, or the Governance Committee, which also provides oversight relative to Human Resources.

Interested candidates are requested to forward a cover letter indicating their reasons for wishing to serve on the NSAA Council, along with a current resume, no later than September 10, 2021.

On April 17 and 18, 2021, during National Oral Health Month, 13 members of the South West Nova DH Study Club participated in their annual oral health display at the Yarmouth Mall. It was a very successful event, with hundreds of visitors over the two-day event, picking up resources and/or asking oral related questions on a variety of dental topics.

# Health Canada regulates UV, ozone devices

On June 7, an interim <u>order</u> was signed requiring manufacturers of UV radiation-emitting and ozonegenerating devices such as lights and wands used for cleaning to apply for authorization under the Pest Control Products Act. This will be regulating UV radiation-emitting and ozoneproducing cleaning devices that may pose a significant risk to Canadians and may not live up to their claims that they kill bacteria or viruses like the one that causes COVID-19 on surfaces and objects.

A warning has been issued saying it is not known how safe and effective these devices are. Health Canada warns that exposure to UV light from UV radiation-emitting devices may cause serious injuries and severe burns to the skin and eyes and inhalation of ozone from ozonegenerating devices may impair lung function, inflame pulmonary tissues, and even cause irreversible lung damage.

If you are using some of these devices currently in your office, ensure that they meet relevant Medical Devices
Requirements and that you are using them according to the manufacturer's direction for use.
