Dental hygienists play a crucial role in the early detection of oral and oropharyngeal cancer. Performing routine extra and intra oral exams on all clients can result in early cancer detection, which has the potential to save lives. The Canadian Cancer Society has alarming statistics on oral cancer rates in Canada. In 2017, nearly five thousand Canadians were diagnosed with oral cancer — 3200 men and 1450 women (Canadian Cancer Society, 2018). Last year over a thousand people died from oral cancer — 860 men and 400 women (Canadian Cancer Society, 2018).

Smoking and the Risk of Oral Cancer

It is widely accepted that cigarette smoking greatly increases your chance of developing oral cancer. Smokers are 5-10 times more likely to develop oral cancer compared to non-smokers. The risk is increased in smokers who also drink alcohol. Exposure to benzopyrene, a chemical found in cigarettes, can

cause the mutation of cells in the oral cavity potentially leading to the development of oral cancer. Of those diagnosed with oral cancer, 37% are expected to die within 5 years. (Government of Canada, 2011) Oral cancer is often diagnosed in the later stages, resulting in poor prognosis. Dental hygienists have the opportunity and professional responsibility to change this by performing routine oral cancer screenings. **Early detection is key to increasing the survival rate**.

From the desk of the Registrar — Accountability and Responsibility

As I write this, I have been working with the 10-year Celebration Planning Committee as we are near the official 10-year mark of dental hygiene self-regulation here in Nova Scotia. This has caused me to reflect on my last 30 years in dental hygiene with a view to how far we've come in this profession overall, and to identify the roles and responsibilities of each dental hygienist as a *regulated member* of this profession.

We are accountable for our actions and must maintain the standards of care that we provide to the public. Remaining current and ensuring that the dental hygiene services we provide are evidence-based, safe, and effective is a top priority. This is not an easy task. Dental hygienists are faced with a continuously changing world, including our health care system. However, dental hygienists continue to rise to the task and the willingness to take on the self-regulation responsibility is another sign of acceptance of that accountability.

We are bound by Practice Standards and a Code of Ethics that help guide how we provide dental hygiene services. As 'critical thinkers', we use the best evidence available when formulating our care plans or community service action plans. As part of a health care team, and an advocate for our clients (individuals or groups of people), we evaluate the care they are receiving, or identify the socioeconomic gaps/barriers that are preventing receipt of care, and work within our 'sphere of influence' to ensure the public's needs are met, and are up to the standard.

As health care professionals, we cannot abdicate our responsibilities and say, "That's another team member's responsibility, not mine". We must "contribute to actions that will support change and facilitate access to care" (Canadian Dental Hygienists Association, 2010, p. 17) and help to "initiate positive changes within our practice environment by using evidence-based literature and the practice standards" (Canadian Dental Hygienists Association, 2010, p. 19).

How does this look 'on the ground'? I will touch on two prime examples to highlight our responsibilities to our clients and the general public. Christina Singer's article about ensuring that we complete a head and neck exam on all clients is a good example of a practice standard that each clinical dental hygienist must integrate into practice. Ensuring the standards of infection prevention and control

are followed in clinical settings is another example. Even if you do not complete the reprocessing in your practice, you must still ensure that you do your part to break the chain of transmission. You are ultimately responsible for ensuring that each client you treat receives sterilized instruments.

If you identify gaps or practices that do not meet the current standard, work within your team to problem-solve how to address these issues. One of the most critical components of dental hygiene practice is communication – with the client, your colleagues, other health care professionals, your local community, government, etc. Use your communication skills to help achieve your desired change. Let's help make the next 10 years of self-regulation even better for Nova Scotians by becoming stronger advocates for high quality, accessible, equitable, dental hygiene care.

What constitutes dental hygiene practice in Nova Scotia?

Section 22 of the Act provides details regarding dental hygiene scope of practice. In conjunction with the Regulations (including Sections 25 and 26: Scope of Practice), the practice of dental hygiene is defined. Only CDHNS members who hold a practising licence may engage in the practice of dental hygiene in Nova Scotia, whether as a volunteer or for remuneration. The practice of dental hygiene includes members who act as clinicians, educators, researchers, administrators, health promoters, and/or consultants. When asked to report your practice hours, do not just calculate the hours you spent providing clinical care, include hours where you provided dental hygiene care in any of the areas noted above — as an educator. researcher, administrator, health promoter, or consultant. This may include positions like dental supply company sales rep, infection prevention and control consultant, and hygiene department manager. All positions count towards accumulation of practice hours and all positions require a CDHNS practising

licence.

2018 Minutes to be approved at the May 24, 2019 AGM

- Registrar Welcome and Announcements

6) Approval of CDHNS AGM Minutes from June 03, 2017 The Chair directed the members' attention to the draft minutes of the 2017 AGM in the Spring 2018 Newsletter and meeting package and asked that they be accepted (as presented) or (as amended).

Deanna Williams presented via live-streaming. Jennifer Clark (Chair) provided a brief summary of Deanna's accomplishments. Her presentation addressed topics such as the origins of regulation, what public interest means,

as the origins of regulation, what public interest means, the accountabilities of a regulator, and the challenges with managing competing interests. She also highlighted current trends across jurisdictions with respect to professional regulation. Her slides were posted in the Members Library, accessible through each Member's Home Page after logging in. The link to her recorded presentation was also posted. Members who viewed the recorded presentation following the AGM, or virtually during the live-streaming, were eligible to claim 0.5 hour of CC credit in category 3 for viewing the presentation.

8) Annual Report / Audit Statements
Jennifer Clark, Chair, and Stacy Bryan, Registrar, presented remarks regarding the Annual Report of the CDHNS noting that it is intended for the general public audience, in addition to the members. It provides information on the structure and function of the College and provides statistics and highlights of the activities of the Council and College for the past year. The Registrar, Stacy Bryan, reviewed the Audit statement as presented in the Annual Report. She addressed the CDHNS's strong financial position and credited the previous Registrar, Patricia Grant, for being in this position.

9) Continuing Competency Committee Report Sonya Bishop, Chair, CDHNS Continuing Competency Committee presented her report. She noted that during the year in question, Feb 1, 2017 to January 31, 2018, 38 members were audited. The results were published in the Spring 2017 newsletter. This year's results were posted in the Spring 2018 newsletter and a total of 42 members were audited on February 3, 2018.

She highlighted a few important points for members based on the CC Committee's audits.

- An FAQ document will be sent out to assist audited members in sending correct documentation.
- Members were also reminded that as of January 2018, all members are now required to record their CC online for their current cycle e.g., if a member's cycle started January 1, 2017 and ends December 31, 2019, all the CC obtained during that time period is to be uploaded in the online system.
- It is often the case that the Committee requests additional information due to lack of documentation provided by members for their CC courses.
- If supporting documentation is not uploaded onto the system, members were reminded to retain all supporting documentation of their courses in case of audit.

Sonya concluded by informing the members that the Committee was launching a comprehensive review of the CCP to make the requirements more streamlined (e.g., improve clarity and make them easier to understand). Members will be asked for feedback at varying steps throughout the process.

Notice from Dalhousie's School of Dental Hygiene: Accepting Applications for the BDH Program

The School of Dental Hygiene is accepting applications for the Bachelor in Dental Hygiene at Dalhousie University. This program offers those with a diploma, the opportunity to complete a degree. The program focuses on three areas:

- Community Outreach and Health Promotion—students must be eligible for licensure in Nova Scotia so that they can work independently in a number of community settings. Settings include but are not limited to, the Oral Cancer Center, the Children's Hospital, a youth shelter and Public Health school initiatives such as the fluoride rinse program.
- Teaching—students learn strategies in clinical and classroom teaching.
 They have an opportunity to teach in the first-year dental hygiene pre-clinic and clinic. Many of the current dental hygiene faculty at Dalhousie are graduates of this program and have benefited from this experience.
- 2. Research—students, under the tutelage of the Research Development Officer at the Faculty of Dentistry, are provided a sound foundation in research and have the opportunity to design and implement a simple, focused research project. Over the years, several research projects have been disseminated through various means including publications in peer-reviewed journals.



Notice from the Quality Assurance Committee

The Quality Assurance (QA) Committee met on February 2, 2019 to perform the annual Continuing Competency (CC) audit for members whose cycle ended December 31, 2018. A total of 38 members were audited. The following decisions were reached at that time. 7 Members were pending (unable to determine if requirements met; more information required), 1 member did not meet requirements, 27 members met requirements, and 3 extensions were granted (due to extenuating circumstances). The member who did not meet requirements submitted an approved action plan to meet the deficiencies, including a learning plan, with a reasonable time for completion.

As of March 26, 2019, all members have met their requirements with the exception of one who has until April 1, 2019 to meet their requirements.

The QA Committee would like to remind members to retain documentation for their CC courses to provide if audited. Proper course verification enables the QA Committee to accurately award CC credits.

Congratulations to those members whose audits were found to be complete with no follow up required. It is strongly recommended that members obtain their CC courses over the entire course of their cycle to fulfill your professional responsibility.

There were a few common concerns we discovered during the audit:

- Please ensure you provide the necessary supporting documentation for all courses that are not offered through the CDHNS, CDHA, Dalhousie's Continuing Dental Education, or Study Clubs who are registered with the CDHNS. This includes a detailed course outline (including course hours) and learning objectives, subject matter of the activity, and the speaker/presenter's qualifications. This requirement applies to study clubs who are registered with other organizations. This information allows us to determine your credit hour eligibility and the correct CCP category.
- "Hands-on courses" qualify for hour for hour credit, not 2 credit hours for every hour attended.

Study Clubs: All Study Club reports that were submitted for 2018 were reviewed to determine eligibility for credits and category assignment.

New Members: The QA Committee is happy to welcome new members Kaleigh Wagner and Palmer Nelson, who were appointed to this Committee as of May 7, 2018. I would also like to thank Brooklyn Hurlbut for her contribution to the Committee.

In the last newsletter, I wrote about the CCP Review that had been undertaken, which included a summary of the survey results and the CCP Requirements changes that were in effect as of January 1, 2019 and others that would be reviewed for the future.

We are the auditors of the College of Dental Hygienists of Nova Scotia and have been engaged to randomly select a sample of members to be audited with regards to their Continuing Competency requirements. We have only been engaged to select the sample and not to audit the member's compliance with their Continuing Competency requirements.

We are not aware of any relationships between the College and ourselves that, in our professional judgement, may reasonably be thought to bear on our independence. We hereby confirm that we are independent with respect to the College within the meaning of the Rules of Professional Conduct of the Institute of Chartered Accountants of Nova Scotia as at November 19, 2018.

We were provided a list of 192 member license numbers from the Registrar with no other information to identify the members to us. Using a random number generator in Microsoft Excel to select a number between 1 and 192 (inclusively), we randomly selected 38 license numbers; of which none were eliminated as duplicate numbers. The list of license numbers was not modified in any way and the first 38 non-duplicate random numbers generated were used for the sample. This sample was provided to the Registrar to be tested.

Oral Cancer Screening Can Save Lives continued...

There has been very little research on the link between cannabis and oral cancer. Studies suggest that smoking cannabis can increase your chance of developing oral cancer. It is challenging to determine the cause of oral cancer due to the fact that many cannabis users also use tobacco products, and cannabis is often smoked in conjunction with tobacco. (Insight from Dana-Farber Cancer Institute, 2016)

Squamous cell carcinoma is the most commonly occurring cancer in the oral cavity (Government of Canada, 2011). When performing the intra oral portion of the extra oral and intra oral exam, you should specifically be looking for red (Erythroplakia) or white (Leukoplakia) lesions or mixed red and white lesions (Erythroleukoplakia). The lesion may present as a unilateral raised, non-healing ulcer with an irregular border. The client may or may not experience pain. The most commonly occurring areas of oral cancer are the lateral and ventral aspects of the tongue, the floor of the mouth and the soft palate (Government of Canada, 2011). A client who presents with a lesion of this nature that has been present for 2 weeks or more, should be referred to a physician, an oral surgeon, or an oral pathologist. If the suspicious area is in the oropharyngeal region, a referral should be made to an Ear, Nose, and Throat specialist.

HPV and the Link to Oropharyngeal Cancer

In recent years, the rate of oropharyngeal cancer has increased due to the rising rate of Human Papilloma Virus (HPV). HPV is the most commonly occurring sexually transmitted infection. A lowered immune system is a risk factor for HPV. (Oral Cancer Foundation, 2019) Most strains of HPV resolve on their own within 2 years. However, some strains remain dormant in the body and have the potential to cause cancer. HPV has affected 75% of sexually active men and women. (The Centre for Disease Control and Prevention, 2018) There are over 200 strains of HPV, although only 9 of those are known to cause cancer. The strain HPV 16 is recognized to be the most harmful, causing cervical, anal, penile and oropharyngeal cancers. (Oral Cancer Foundation, 2019) Oropharyngeal cancers attributed to this strain of HPV have primarily been found in the tonsils, tonsillar crypts, base of the tongue, soft palate and a small number in the oral cavity. Men are four times more likely to develop oropharyngeal cancer than women. (Oral Cancer Foundation, 2019) Squamous cell carcinoma is the most common oropharyngeal cancer and is responsible for 90% of oropharyngeal cancers (Canadian Cancer Society, 2019).

HPV Vaccines

With parental consent, HPV vaccines are now provided to children aged 11 and 12 in Canada (The Centre for Disease Control and Prevention, 2018). Adolescents and young adults (14-26 years) can also receive the vaccination, however they require an additional dose (3 shots, compared to 2 for children). Women age (26-45 years) can receive the vaccination, however it is less effective as most sexually active adults have already come in contact with HPV. Men can only be vaccinated between the ages of 11-26. The vaccine is intended to prevent HPV infections and will not treat an active infection. (Centre for Disease Control and Prevention, 2016) There are currently 3 different types of HPV vaccines:

- 1. Cervarix protects females against HPV 16 and HPV 18; 2 strains of HPV that can cause cancer.
- 2. Gardasil® protects males and females against HPV 16 and HPV 18. It also protects against 2 types of HPV that can cause genital warts.
- 3. Gardasil® 9 protects against 2 types HPV that can cause genital warts, and 9 types of HPV that cause cancer, including HPV 16 and HPV 18. (Canadian Cancer Society, 2019)

Oral Cancer Screening Can Save Lives continued...

Extra Oral and Intra Oral Exam

Performing routine extra oral and intra oral exams is extremely important in early detection of oral cancers. The first step is to take the client's medical history, including noting if they smoke, and/or drink alcohol. Dental hygienists typically see the average client more frequently than a physician, providing us with the opportunity to perform extra oral and intra oral exams on a more frequent basis. We should all be performing extra oral and intra oral exams, including oral cancer screenings, at every dental hygiene visit on every client. In addition to in-office screenings, it is also very important to teach your client what to look for in their own mouth. Use a mirror and show them what areas to examine (palate, tongue, lips, the floor of the mouth, buccal mucosa and back of the throat) and what signs to look for.

There are different techniques and methods used to perform the extra and intra oral exam. The most important thing is to consistently use a logical, systematic approach

that palpates all of the potential risk areas. The whole exam can be completed in as little as 2 minutes!

Extra Oral (Adapted from Gehrig, 2018; Canadian Dental Hygienists Association, 2015)

- Observe facial symmetry, as well as the skin of the head, neck, and face.
- Palpate the following lymph nodes: occipital nodes (base of the skull) pre and post auricular (in front and behind ear), submental (under the chin), submandibular (under the mandible), cervical (both sides of the neck) and supraclavicular (above the clavicle)
- Palpate the salivary glands: parotid and submandibular
- Palpate the thyroid gland and assess any restricted movement when swallowing
- Palpate and assess the TMI for clicking, tenderness and restricted movement

CDHA (2015) provides the following steps to palpate all of the areas noted in the bullets above.



Extraoral Assessment Head & Neck

The dental hygienist examines and palpates the following areas:



Palpate jaw joint for clicking, tenderness or restricted movement when the mouth is opened and closed.



Palpate cervical lymph nodes along both sides of the neck.



Palpate preauricular lymph nodes in front of the ear.



Palpate the parotid salivary gland and the masseter muscle in the cheeks for swelling or tenderness.



Palpate supraclavicular lymph nodes above both sides of the collar bone.



Palpate thyroid gland for restricted movement during swallowing.



Palpate submental lymph nodes under the chin area.



Palpate occipital lymph nodes at the base of the skull.



Palpate submandibular lymph nodes under the angle of the jaw.



Palpate postauricular lymph nodes behind the ear.

Intra Oral (Adapted from Gehrig, 2018; Canadian Dental Hygienists Association, 2015)

- Visually inspect the oral cavity and oropharynx including observing the gingiva for abnormalities
- Palpate the lips and buccal mucosa
- Palpate the floor of the mouth
- Palpate the lateral, ventral and base of the tongue by asking the client to stick their tongue out and holding it with gauze
- Palpate the hard and soft palate
- Inspect the tonsils and oropharynx by depressing the tongue
- Examine the salivary gland function: check both Stenson ducts for parotid function and the Wharton duct for submandibular and sublingual gland function.

CDHA (2015) provides the following steps to palpate all of the areas noted in the bullets above.



Intraoral Assessment Lips & Mouth

The dental hygienist pays close attention to changes in colour, size, and texture when examining the following areas:



Lips: examine with finger and thumb.



Gingiva or gums: look for red or white patches or swelling, hardness or tenderness.



While the tongue is touching the roof of the mouth, visually examine and palpate the surface for any swelling, red or white patches or hard spots.

Upper and lower lip: examine the gingiva or gums and inside of the lip for any changes.



When the tongue is straight out, palpate and visually examine the upper surface, looking as far back as can be seen for any swelling, texture or colour changes.



While the tongue is elevated, visually examine and palpate the area bimanually for any swelling, hard spots or changes in colour or texture.



Inside of the cheeks: look for red or white patches or swelling, hardness or tenderness.



Holding the tongue to the side, examine each side for any red or white patches, and palpate for tenderness, swelling or hard spots.



Have the client take a deep breath in through the mouth and say "aah." Depress the tongue and examine the throat and palate for signs of swelling, texture or colour change.

Conclusion

Dental hygienists have the knowledge, ability, opportunity and professional responsibility to perform complete extra and intra oral exams including oral cancer screenings. It can be completed in as little as 2 minutes. As oral health professionals dedicated to prevention, let's do more for our clients:

- Do you discuss the detrimental health effects of smoking with your clients, including the increased risk for oral cancer? Do you provide smoking cessation inoffice and/or referrals to local resources?
- Do you discuss HPV and the option for the HPV vaccine?
- Do you teach your clients how to do a self-oral exam and educate them on what to look for and what to do?

If you have answered "no" to any of the above questions, I encourage you to consider introducing these aspects into your routine practice. Our commitment to performing oral cancer screenings on every client at every visit has the potential to save lives.

CPR Requirements Effective on or after November 1, 2018

For all new registrants applying for registration or a practising licence on or after November 1, 2018, and all CDHNS members who are renewing for their licence for the November 1, 2019 to October 31, 2020 renewal year, the level of CPR certification must include, at a minimum, classroom instruction and practicum experience related to:

one and two-person rescuer chest compressions fo
adults, children and infants;

- ☐ one and two-person rescuer adult, child and infant bag-valve mask technique and rescue breathing;
- ☐ relief of choking in adults, children and infants; and
- ☐ use of an automated external defibrillator (AED).

A hands-on component is required. Please ensure that the CPR course you take has a hands-on component. Online CPR courses are not acceptable. CPR course must include classroom instruction and practicum experience.

What CPR does this requirement equate to for different organizations?

To assist you in understanding which CPR meets the list of requirements set by Council, a summary is provided below based on the organization's current offerings and levels.

St. John Ambulance

Based on the current course offerings and levels, the accepted course from St. John Ambulance would be Health Care Provider (HCP) CPR.

Heart and Stroke Foundation

Based on the current course offerings and levels, the accepted course from the Heart and Stroke Foundation would be Basic Life Support (BLS).

Waterpik Oral Health for

Professionals

Red Cross CPR

Based on the current course offerings and levels, the accepted course from the Red Cross would be CPR/AED Level Health Care Provider (HCP).

Assigning Credit Hours for Online Courses


