



About the Mural Photo Project:

The Dartmouth General Hospital Foundation invites you to participate in our mural photo contest to have your work chosen to be represented in our hospital! With Dartmouth General's \$150M Redevelopment Project well underway, new spaces will soon be opened. As part of the hospital's interior design for this project, murals will be installed in these new areas. Our community outreach team invites <u>all members of our community</u> to participate in the photo contest to select these murals and help shape the new areas of the Dartmouth General. There are 11 larger landscape murals in multiple waiting areas and hallways throughout the hospital. There are also 36 smaller portrait murals in patient rooms on our new 5th floor inpatient unit. We ask you to submit a piece that reflects the theme, "City of Lakes", a theme that embodies Dartmouth and showcases different local bodies of water. The Foundation, with help of a selection committee, will evaluate and determine which photography is chosen for each of the murals. If your work is chosen, your name will be recognized. We encourage everyone to submit a photo and help brighten the lives of our patients and visitors.

Criteria for Submissions/Official Rules:

Term:

The Mural Photo Project begins April 23, 2019 and ends June 21, 2019. ALL ENTRIES MUST BE RECEIVED BY JUNE 21, 2019 AT 11:59PM. Information on how to enter form part of these official rules ("Official Rules"). By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules.

Who May Enter:

The contest is open to all, professional and amateur, regardless of age, gender, or nationality. Entrants under 18 years of age require the permission of a parent or guardian. By entering the contest, entrants under 18 years of age indicate that they have obtained the permission of a parent or guardian in the attached entry form.

How to Enter:

Each entry consists of an entry form and submission of your photograph(s). To enter, email **info.dghfoundation@dghfoundation.ca** with the subject line 'Mural Photo Contest'; complete the attached entry form with the required information, including your name, address, telephone number, email address, and photo title/caption; and send by email.

The theme is 'City of Lakes' and must feature bodies of water in the Dartmouth area (i.e Sullivans Pond, Banook Lake, Fisherman's Cove, Shubie Canal, the Halifax Harbour) to match with the hospitals coordinating wayfinding signage. There is no limit on the number of entries per person. Each entry must comply with the official rules as well as the following requirements:

1. Photographs must be high resolution (minimum 300dpi) and in digital format. Only submitted entries via email at **info.dghfoundation@dghfoundation.ca** will be eligible. No print or film submissions will be accepted for entry into this Contest. All digital files must be in JPEG or .jpg format. Upload images with the original pixel size. Do not scale and do not change the resolution. Note: the larger murals are in landscape format, while the smaller murals are in portrait format.





- 2. The photograph, in its entirety, must be a single work of original material taken by the Contest entrant. By entering the Contest, entrant represents, acknowledges, and warrants that the submitted photograph is an original work created solely by the entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph. Further, that no third party can hold any claims or any objections regarding the rights granted to the DGH Foundation.
- 3. Entrant must agree to the DGH Foundation having the rights to use their image (photo credit will be recognized) and their name published. This approval will be located on the entry form.
- 4. The photograph must not contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.
- 5. The caption must be complete and accurate, sufficient to convey the circumstances in which the photograph was taken. Disguising or misrepresenting the origin of your content will be unaccepted.
- 6. Watermarks are unacceptable.
- Entries must be submitted via the official contest platform by emailing info.dghfoundation@dghfoundation.ca. Entries sent in other ways will not be accepted.

The conditions set out in these requirements are binding, and the DGH Foundation reserves the right to refuse or exclude any entry at its own discretion.

Judging:

Judging consists of one round of evaluation. There will be an unbiased panel of 4-5 judges that include 1 member from the Foundation, 1 member from the Nova Scotia Health Authority, 1 member from the provincial government, 1 member of the public advisory council, and 1 community member. Each judge in the panel will select the entries among all eligible entries. Each photo will be judged on the following: creativity, photographic quality and your perception on the theme. Together, the judges will come to a consensus. After the judging concludes, the winners will be notified via contact information provided.

Releases:

If the photograph contains any material or elements that are not owned by the entrant and/or which are subject to the rights of third parties, and/or if any persons appear in the photograph, the entrant is responsible for obtaining, prior to submission of the photograph, any and all releases and consents necessary to permit the exhibition and use of the photograph in the manner set forth in these Official Rules. If any person appearing in any photograph is under the age of majority, the signature of a parent or legal guardian is required on each release. These release forms must be provided with submission.
