Often investigations find human error as a main contributor to accidents. Rather than a conclusion, this should be the starting point of an in depth investigation that will not only determine the various factors that lead to the error, but allow for better design of the equipment, environment, processes, systems and training related to the related job tasks.

Participants will learn how to systematically investigate for the physical, cognitive/mental and organizational factors that may have contributed to the accident, near miss or unsafe conditions.

Using case studies, participants will develop and rehearse practical skills necessary to conduct investigations such as interviewing, fact gathering, constructing sequence of events diagrams, identifying and analyzing unsafe behaviours, synthesizing contributing factors and providing safety recommendations.

Biography: Maury Hill

Maury Hill served as the Transportation Safety Board's technical authority for human factors issues from 1992 to 2000. As such, he was responsible for the provision of human factors support to accident and incident investigations. For example, he was the lead human factors investigator for several major rail marine and aviation accidents, for example the Swissair Flight 111 accident at Peggy's Cove. He used a systems approach to program development and implementation to successfully introduce a new approach to investigations, focusing on a systematic approach to the investigating for human factors in accident causation. The approach has received wide acceptance by international safety organizations and industries.

In 2000, he became Manager, Macro Analysis, for the TSB, responsible for planning and directing a program of Macro Analysis projects, including cross-modal studies, in which trends, hazards and systemic safety deficiencies in the national transportation system are identified, analyzed and validated. Maury currently is providing authoritative consulting services to industry, government and universities in such areas as safety management and safety investigations, with a particular focus on human factors, through his firm Adaptive Safety Concepts.

He has an Honours Bachelor of Arts degree in Psychology from Carleton University, and a Master of Science in Ergonomics (Human Factors) degree from Loughborough University, U.K.



Participative Ergonomics: What does it mean and how does it work?



From an empirical and philosophical viewpoint, involving people in the development of their own work environment is the right thing to do. The practice of ergonomics has embraced the approach but there are different interpretations of the term and how to put it into action.

The presentation will explore its use in the workplace change process and reflect on lessons from the author's experiences.

Biography:

Dr. Richard Wells has worked in the areas of biomechanics of musculoskeletal injury and disorders, ergonomics, exposure assessment, participative ergonomics, and workplace intervention evaluation. He has experience in basic as well as applied research, knowledge transfer, and in developing large, collaborative research programs to work towards an integrated understanding and approach to the prevention of musculoskeletal disorders at work.

He was trained as a mechanical engineer at the University of Manchester, England and McMaster University, Ontario and is the Director of the Centre of Research Expertise for the Prevention of Musculoskeletal Disorders and a professor in the Department of Kinesiology, Faculty of Applied Sciences at the University of Waterloo, Ontario. He is also an Adjunct Scientist at the Institute for Work & Health in Toronto and a Certified Ergonomist in Canada.

The session will provide an overview of several industrial ergonomic projects and identify the approach, strategy, metrics, justification and project implementation method incorporated.

Debbie Schwartzentruber is a Canadian Certified Professional Ergonomist. She obtained her BIS (Kinesiology) from the University of Waterloo. Debbie has worked for Maple Leaf Foods (formerly Schneider Foods) for close to 20 years as their principal ergonomist, working with various employee, safety, union and management teams across Canada. She has developed and delivered industry specific manuals and training, PDA structure and strategy for prioritizing and analyzing injuries to obtain large capital designations for funding projects. She has been project manager and leader for multiple ergonomic design and equipment projects and utilizes Six Sigma metrics to validate direction and support ROI.

MEMORIAL UNIVERSITY

Compared to onshore facilities, offshore industries face added challenges in mitigating risk of accident and injury. This presentation identifies how current ergonomics and health and safety practices need to be improved, gaps in existing research and regulations and barriers to creating an improved sectoral culture of safety.

Dr. MacKinnon is Co-Director of SafetyNet Centre for Occupational Health and Safety Research, is Director of the Interdisciplinary PhD Program and an Associate Professor in the School of Human Kinetics at Memorial University of Newfoundland, and holds a cross-appointment with the Faculty of Applied Science and Engineering. His research includes health & safety in marine systems, biomechanical risk factors to injury and the impact of participatory ergonomics on safety performance. Dr. MacKinnon holds a PhD in Biomedical Engineering from the University of Cape Town, South Africa.

This session will provide an overview of the Participatory Ergonomics strategy adopted by the Workers' Compensation Board of Nova Scotia to advance injury prevention in the province. Highlights will include discussions around both the challenges and successes of implementing this particular type of initiative. Lastly, it will give participants an idea of how to measure current progress and plan for the eventual maturing of the ergonomics process within organizations.

Darren MacDonald is a Certified Professional Ergonomist and Ergonomics Process Lead with the WCB in Nova Scotia. Darren's work experience spans all industries in a number of countries worldwide. He has been working in this capacity since March 2007 and is responsible for improving working conditions with ergonomic principles at the Labrador City site and the port city Sept-Iles Quebec. Neil moved from the Toronto, Ontario area where he left the ergonomic consulting world to prevent MSDs in a large industrial setting. Neil graduated from York University with a Specialized Honours in Kinesiology and Heath Science.

3. Paul Batstone Award (submit by January 30th, 2009)

The Paul Batstone Memorial Fund has been established by ACE – Atlantic in honour of the tradition that the late Paul Batstone began during his life as an active ACE Member. This \$400 award is offered to a university or college student who lives in the province of Newfoundland and Labrador so they have the opportunity to attend the ACE Atlantic Regional Workshop/Conference on Mar. 26/27th, 2009 in Fredericton, New Brunswick. Preference will be given to students who submit an abstract for work which they would like to present at the conference.

To apply for the Paul Batstone Fund Award a student must submit an application package to ACE Atlantic by January 30th, 2009.

There is no formal application document, however the application must include the following: 1.A one-paragraph (150 words) summary of the applicant's current studies and how they relate to ergonomics. 2.A summary of the work which they wish to present at the conference if they are choosing to do so. 3.An application letter from the student's Department Chairperson or Academic Supervisor and a statement from the student.

The application letter should:

a. Be written on the Institutions official notepaper.

- b. Provide the full name and home address of the student.
- c. Provide the name of the student's academic programme, year started, and year of expected graduation.

d. Details of any special courses, programme options, or similar academic background currently being taken, or completed, by the student related to the discipline of Ergonomics/Human Factors.

e. State current academic standing of the student – their position on the institution's academic achievement scale. f. Provide an estimated budget of all costs (travel, hotel, registration, etc.).

g. Indicate what other sources of support, monetary or in-kind, are being or can be made available to the student. h. Include a short paragraph indicating any special circumstances which the Board should consider in making its evaluation and decision.

i. Contain a separate document, authored and signed by the student (not to exceed one page), outlining their rationale for attending the specific event, and what they anticipate will be the outcomes which will assist them in furthering their academic studies.

Awards will be made based on:

- a) the student's statement contained in their document;
- b) their academic standing among the peers;
- c) the institution's indication of special need or circumstances

Candidates will be notified of the Board's decision by February 14, 2009.
