Who is eligible for the grants?


To be eligible, the individual must have a permanent, probationary, or term contract and be a member of the NSTU, PSAANS, or RTO at the time of application. Please be advised that applicants that have received a grant within the last 2 years will not be eligible.

What is the selection process for the **EDUWellness Grants?v**

The NSTU Group Insurance Trustees will award 10 grants valued at up to \$1,500 each. Grants will be scored following the rubric that can be found at https://nstuinsurance.ca/grants/the-eduwellness-grant and awarded to the applicants with the highest overall scores. Please be advised that not all applications will be awarded grants.

What is the deadline to submit applications for the EDUWellness Grants?

Applications must be submitted on/or before 11:59pm on January 15, 2026. Completed projects are due no later than May 31, 2026.

Regional Agreement (HRCE) **ARTICLE 4** BEREAVEMENT/SPECIAL **LEAVES**

4.04 In cases where there is a death of a member of the school staff or a member of the student body, teachers may be permitted to attend the funeral service in consultation with Human Resources Staff. The principal will maintain the secure operation of the school.

NSTU Benefits at a glance... Optional Critical Illness Insurance

Cost Sharing: Member pays 100%

Coverage:

- Units of \$10,000 up to \$50,000 with no medical evidence of insurability (proof of health)
- Additional amount available to a maximum of \$300,000 medical evidence of insurability required (proof of health)
- Lump sum tax free payment if diagnosed with one of the eligible critical illnesses
- 29 Conditions covered for member & spouse
- 20 Conditions covered for dependent children
- Pre-existing conditions clause applies unless you submit a medical questionnaire and are approved for coverage
- Benefits not payable for any life-threatening cancer made within 90 days following effective date and if diagnosed with one of the covered illnesses, there is a 30 day survival period
- Covered until 75th birthday for member and spouse.
 Dependent children covered until they are no longer eligible

Early Retirement Incentive Program

Any member who is retiring this year and interested in an Early Retirement Incentive Plan (ERIP) must apply by December 31, 2024. Any retiring teacher should reach out to the Local's NSTU Executive Staff Officers, Wally Fiander and Tim MacLeod, for details. ERIP is located under Article 38 as well as Appendix A and is found in the Teachers' Provincial Agreement (TPA). The Appendix explains the application process, conditions and other pertinent information. The application is available under HRCE Internal SharePoint.

Cash for Classrooms Receipts are Due February 27th

The PD Committee has processed all Cash for Classroom applications. Those who have received an approval email are reminded to verify the instructions on the attachments. **Make sure the purchase is DATED NOVEMBER 11th or later and not before. REPS or Members: If you collect forms and receipts for your school, please ensure all receipts are stapled to the appropriate form before collecting and put in a large envelope. Have each member sign a form stating they have given you their forms with receipts but that they have taken copies of said forms and receipts for their own records in case something happens.

We appreciate your patience while we process over 500 expense forms and receipts. Cheques will be issued as soon as the committee is able to verify the expense forms/receipts and the Treasurer/Finance committee is able to process them. Any receipts processed in December/early January will be mailed to members.

Halifax County Local Conference Fund

Amount: Up to \$800 CDN

Members can use to attend a conference, workshop, seminar, clinic, symposium, institute or other approved PD opportunity. Can receive once every 2 years.

Eligibility: Must be a permanent, probationary or term teacher of the Halifax County Local only. Please note: NSTU Professional Development Day (October Conference) and credit courses are not funded by this grant. For such funding, go to HRCE Internal Sharepoint for more information.
