Dates of Meetings

The Committee held meetings on November 2, 2007, January 11, 2008 and April 4, 2008. At the first meeting the Committee reviewed its mandate and was provided with updates on teacher affiliate negotiations in the Atlantic Provinces and across Canada.

Activities

Conference

The Member Services Committee organized the Member Services Conference held on April 4 & 5, 2008 at the Chocolate Lake Hotel. The keynote address on the topic of School Safety was delivered by Constable Mark Young. Sessions were held on Atlantic Canadian Teacher Negotiations, the status of NSTU Negotiations with the Province, the Boards, and the Community College and a session to raise awareness among the membership of issues pertaining to the Community College. The next Member Services conference will occur in Spring 2010.

Budget

\$8,280 was budgeted for the Committee's ordinary activities for the 2007-08 school year. \$4,843.58 was the actual amount spent.

\$9,174 was budgeted for the 2008 Member Services Conference. \$16,190.50 was the actual cost of the conference. The overage represents Committee members expenses for the April meeting (which coincided with the conference) being attributed to the Member Services Conference instead of the ordinary budget, and higher-than-normal hotel costs due to lack of room availability at the NSTU contract hotel.
