

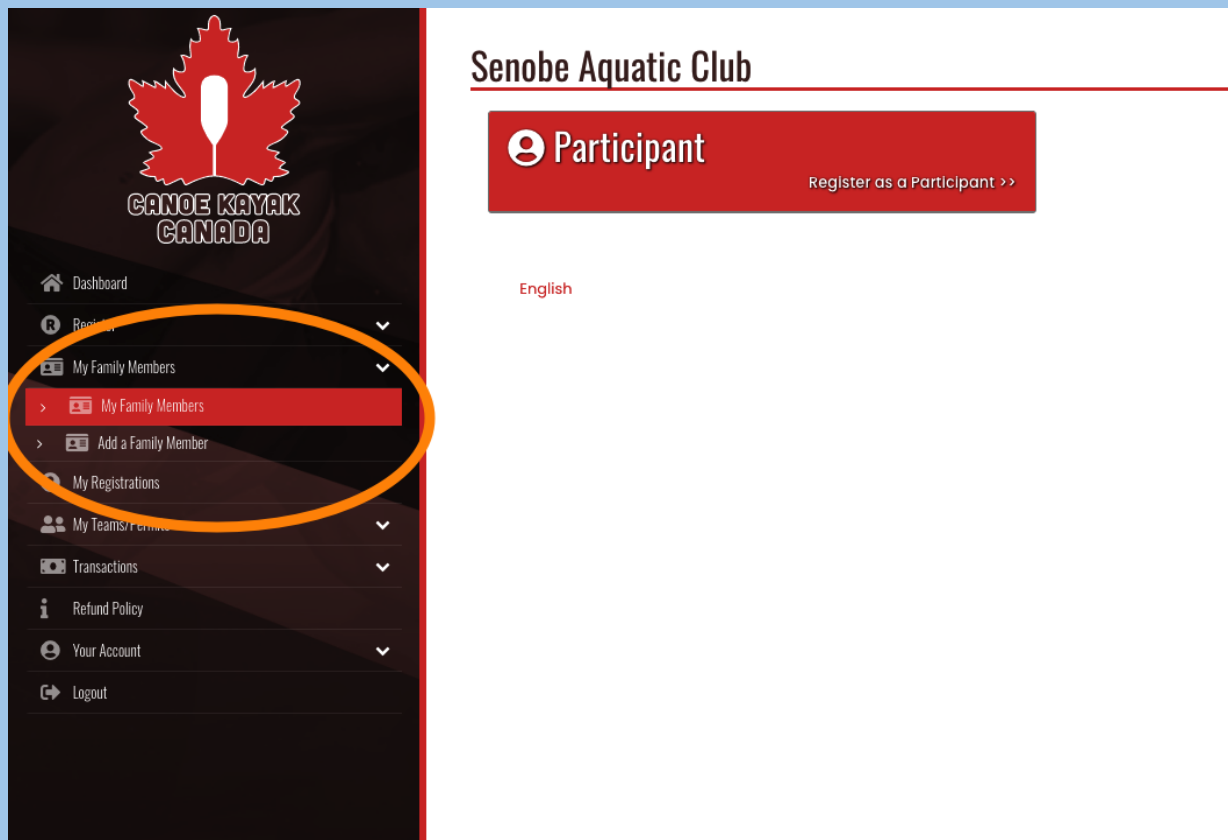
Registration with the RAMP system

If you have used RAMP to register for other sports, you may have already entered information into the system. If not, you are encouraged to create your RAMP account prior to registering. This will save you time when you need to register.

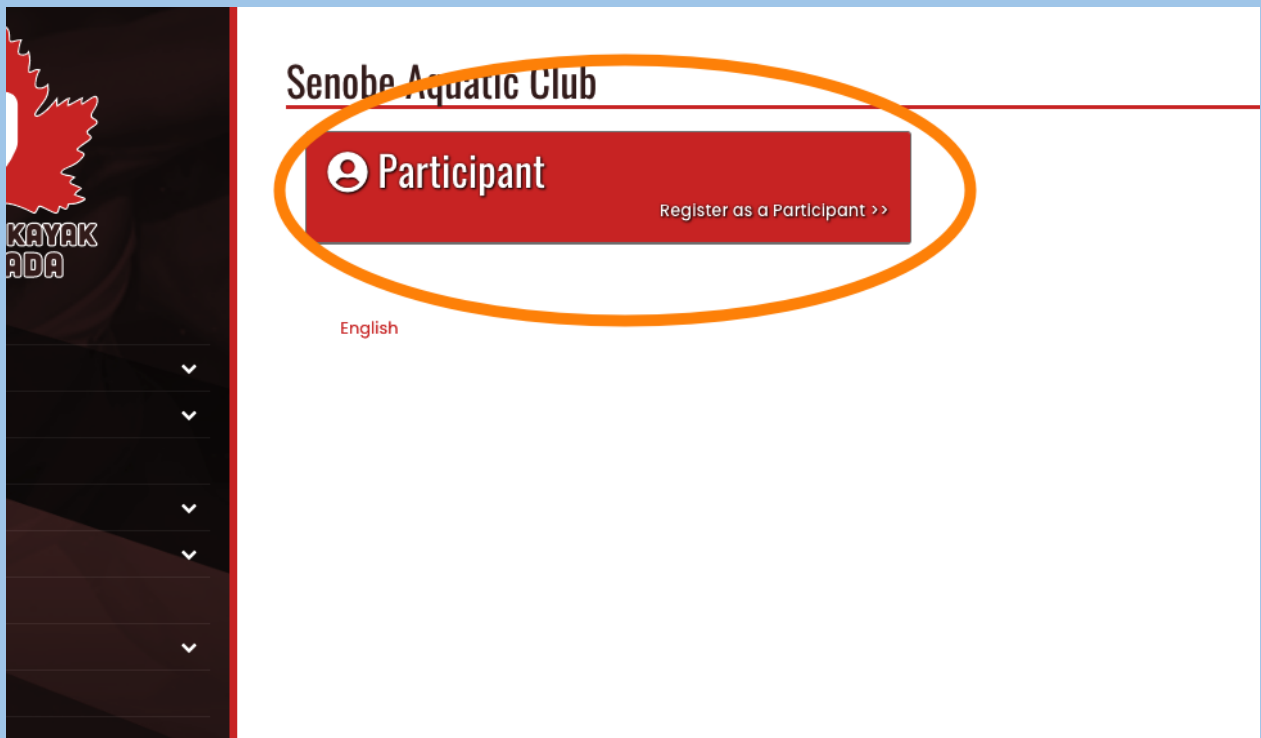

Use this option to register **additional children** for the summer program. You may add as many of these packages as you need, but you must first register a **First Child**.

Children who will not be paddling (ex. children in kiddie kayak) do not need to be registered as paddlers, but will be included in the family membership. To be enrolled in U7-U18 paddling programs, children must be registered as paddlers.

In order to enrol your child in the **Off-Water supervision** program, they must be registered as a paddler.

Boat storage, and **lockers** are also added as separate packages prior to checkout. These can be purchased at a later date, although both are first come first serve.

Payments

The price shown **includes CKC fees** for your child's specific age division.

Split payment option.

At checkout, you may choose to pay all at once using your **credit card**. You may also choose to split your payments.

Split payments are broken down as 1/3 at checkout, 1/3 taken on April 30th, and 1/3 taken on June 30th. Split payments will be taken automatically on those dates.

Registrant must be born between 1/1/2012 and 12/31/2017.

- You will have multiple package options available for each paddler you wish to register including Off-water supervision, lockers, and boat storage.
- Check all packages that you wish to purchase.
- Off-water supervision must be accompanied by **summer paddling** for your child.
- When registering your first child, choose the **Summer Paddling - First child** package, as well as any other packages you are adding for THAT CHILD.
- Subsequent children can be registered using the **Summer Paddling - Additional child** package option + additional packages for that child.
- You will need to complete a separate checkout for each child.
