3. **The User will not solicit customers in the Mall and will stay at the community booth at all times for the purposes of fund raising.**

Please check with Security (902-877-0705) if you are not sure where to go and they will direct you to the correct booth. Our Mall hours are Monday to Friday 9:30 am to 7:00 pm, Saturday 9:30 am to 6:00 pm and Sunday 12:00 pm – 5:00 pm.

4. The User shall, at least two (2) working days before it uses the Area, provide the Owner with proof satisfactory to the Owner that it carries and has in full force and effect, public liability and property damage insurance in connection with the use of the Area, in an amount of not less than Five Million Dollars (\$5,000,000.00). **Such insurance shall name and protect the User and the Owners and the Property Manager company.**
5. The User agrees to report the total raised at the end of their use of the Community Booth to Sunnyside Mall Marketing at 902-835-5099 Ext # 3 or [marketing@sunnysidemall.ca](mailto:marketing@sunnysidemall.ca) or at the end of the fundraising campaign if the entire campaign is being run out of Sunnyside Mall.
6. The User agrees to indemnify and hold harmless the Owner from and against all liability, claims, actions, damages, expenses or loss due to or arising from either the User's use of the Area or the acts or neglect of the User's employees or those for whom it is in law responsible.
7. This Agreement shall not be assigned or transferred by the User.
8. The User shall submit to the Owner for its prior approval, any advertisement, message, presentation, notice and/or display which the User shall use or intend to use in connection with use of the Area.
9. This Agreement may be terminated within 24 hours written notice by either party. The Owner reserves the right to relocate User at any time.
10. This Agreement shall be governed by the laws of the Province of Nova Scotia.
