Nova Scotia Context

To support the implementation of the Proof of Vaccination policy in Nova Scotia:

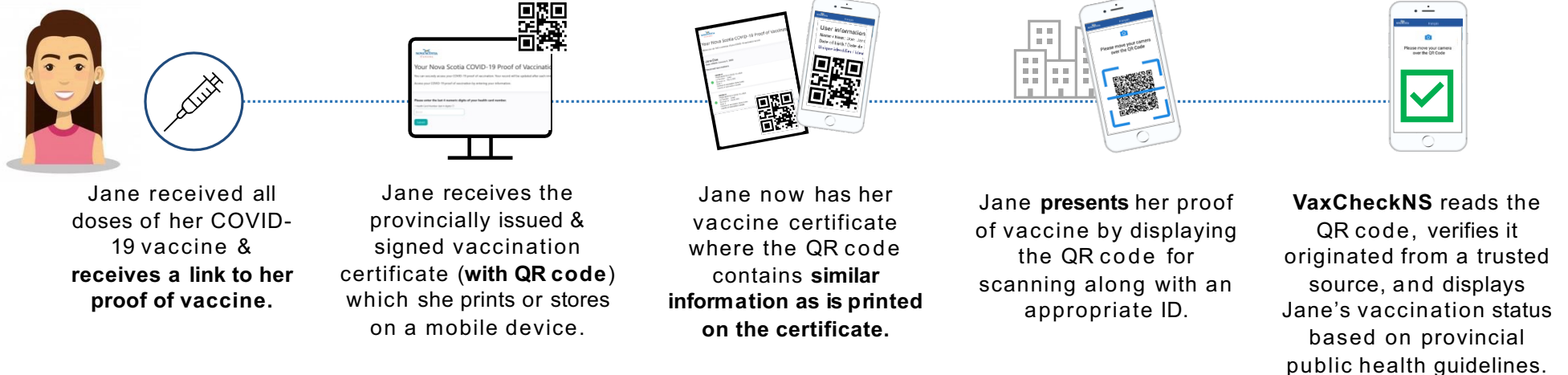
- On October 1st, the Province launched an enhanced standard proof of vaccination (POV) that has a quick response (QR) code that can be scanned by a business or organization that requires a person's proof of full vaccination.
- On October 22, Nova Scotia will implement VaxCheckNS – which is a freely available QR scanner app that can scan this code and provide a simple green “confirmed” response or a red “sorry” response.
- VaxCheckNS will be the preferred method of providing and checking proof of full vaccination as it can make the process easier and protect people's personal health information and their vaccination status.

Our objective today is to provide an overview of this digital proof of vaccination verification process

User Journey: digital vaccine verification

Once the **VaxCheckNS** launches on **October 22**, organizations and venues will have the opportunity to freely download the app from the Apple and Google Play stores, and use this tool to simply scan the unique QR codes on vaccine certificates to verify their authenticity and quickly determine a person's vaccination status.



** NS Visitors or people with older versions of the Proof of vaccination form may still need to follow a manual verification process**
