**A Professional Theatre Company for the purposes of TNS Membership is an organization which:**

- 1) Engages a majority (51% +) of Professional Artists\*

\*Theatre Nova Scotia adopts the Canada Council definition of professional artist: A professional artist is someone who has specialized training in the field (not necessarily in academic institutions), is recognized as such by peers (artists working in the same artistic tradition), has a history of public presentation or publication, and the intent make a living from their craft.

- 2) Pays all professional artists required for the running of a performance, including but not limited to actors, stage managers and technicians, no less than \$300\* per week for each performance week or any part thereof

\*Theatre Nova Scotia does not endorse this amount as an industry standard of any kind, however has accepted this figure for the purposes of categorization. Such detail will be reviewed each year.
