Use the photocopier and printer at the TNS office in Halifax to produce high quality scripts, posters, brochures, programs and more in greyscale or full colour at discounted rates. Call ahead to make sure we are in the office, then bring your documents in PDF format on a USB drive. Bring your own specialized paper, or use ours. We have letter, legal and 11x17" sizes. You can now produce pre-stapled half fold documents automatically. Feel free to use our stapler, three hole punch and paper cutter while you're here at no extra charge.
