MANUFACTURER'S LIMITED WARRANTY FOR RESIDENTIAL USE

Effective June 1st, 2001

PolyTech Products Ltd. provides the following limited warranty on its solid vinyl windows and doors as long as you own your windows and doors (warranty is not transferable):

I. VINYL CASEMENT REPLACEMENTS (FRAME AND SASH)

The vinyl casement on all manufactured windows and doors shall remain free from blistering, peeling, or cracking caused by manufacturing or vinyl compositional defects when subject to normal environmental conditions and reasonable residential usage for a LIFETIME from the date of purchase or as long as you own your windows and provided that no paint, varnish, or other coating is applied to the vinyl in the event of which this warranty is void.

II. SEALED THERMAL UNITS

The sealed thermal unit shall remain free from the introduction of foreign substance including dust or moisture caused by manufacturer's defect for a period of TWENTY (20) YEARS from the date of purchase or as long as you own your windows when subject to reasonable residential usage and under normal environmental conditions but this warranty shall be null and void in the event of breakage or cracking of glass comprising the sealed thermal unit.

III. HARDWARE

The window and door hardware (the tilt and turn mechanism, operational handles and locking device) shall remain free from manufacturer's defect for a period of TWENTY (20) YEARS from the date of purchase or as long as you own your windows when subject to reasonable residential usage and under normal environmental conditions and comply with PolyTech's maximum operating window and door size. PolyTech shall not be liable for and this warranty does not apply to hardware broken or damage caused by improper installation and misuse.

RESTRICTIONS AND LIMITATIONS

PolyTech's liability is limited solely and exclusively to the supply or replacement material, and to labour to repair or replace in the first year.

PolyTech shall not be liable for, and this warranty does not apply to, any failure, defect, or damage resulting from or connected with: misuse, abuse, neglect, or improper handling or storage: improper installation or installation not in strict adherence to PolyTech's written instructions, PolyTech shall not be liable, and this warranty does not apply to PolyTech screens.

Only PolyTech Products Ltd. or its representatives will decide on the method and extent of repairs, and cost to be required for labour and poats to be used for repair and/or of the replacements to be done during & after the prescribed warranty period. PolyTech will accept no responsibility for the decisions taken by others than those mentioned above.

The above limited warranty applies only to the installation of PolyTech Product Ltd.'s doors and/or windows for residential use. In the event that the Purchaser intends to use the PolyTech products for any commercial purpose or usage, the purchaser shall establish in writing the nature of the commercial use and on that basis, PolyTech Products Ltd. may or may not in its own discretion, provide a manufacturer's written warranty on its windows and/or doors.

There are NO VERBAL WARRANTIES OR REPRESENTATIONS extended to the Purchaser by PolyTech Products Ltd. and the above limited warranty or any other written warranty provided by PolyTech Products Ltd. is the only warranty provided by PolyTech Products Ltd.

This limited warranty shall be void in the event that damage is caused to any part of PolyTech Products Ltd.'s windows or doors as a result of unanticipated events including but not limited to lightning, fire, windstorm, tornado, hurricane, flood, earth tremor, subsidence, explosion or acts of God.
